Note:

Caution should be taken when applying the threshold for firms operating within the regulated industries, i.e. fuel industry, as third of their turnover consists of taxes and mandatory government levies and given the regulated low profit margins with sizable turnovers it is important to remain sustainable. Therefore, this should be taken into consideration when determining the size levels of small enterprises for such firms operating within this space.
